

## SERVICES PROVIDED BY LAKE STEVENS FIRE

Lake Stevens Fire, located in the central portion of Snohomish County, is the fifth largest fire service provider in Snohomish County, Washington. Within its boundaries resides the areas of City of Lake Stevens, Machias, Soper Hill, Cavalero, Glennwood, Georgetown, Sunnyside and many more. Overall Lake Stevens Fire provides Fire, Emergency Medical Services (EMS), and Rescue service to an estimated 35,644 citizens in approximately 41.8 square miles of land and water.

In 2009 Lake Stevens Fire responded to over 4,300 incidents. The majority of our calls were classified as medical calls.

The Fire District responds to alarms from three stations strategically located throughout its boundaries. Stations 81 & 82 are primary stations that cover 89% of all emergency alarms received each year. They are staffed 24 hours a day, 7 days a week. Station 83 located on our southern border is considered a secondary station and is equipped with apparatus and equipment similar to the two primary stations.

Fire services are provided using nationally recognized class "A" fire engines. These fire engines are outfitted with fire fighting equipment in accordance with National Fire Protection Association standards.

EMS resources consist of two Advanced Life Support (ALS) paramedic units and three Basic Life Support (BLS) units. Additionally, all the department's fire engines are equipped with medical equipment and supplies.

Lake Stevens Fire also has a 24 foot fire rescue boat moored at the northern end of Lake Stevens Lake year-round.
